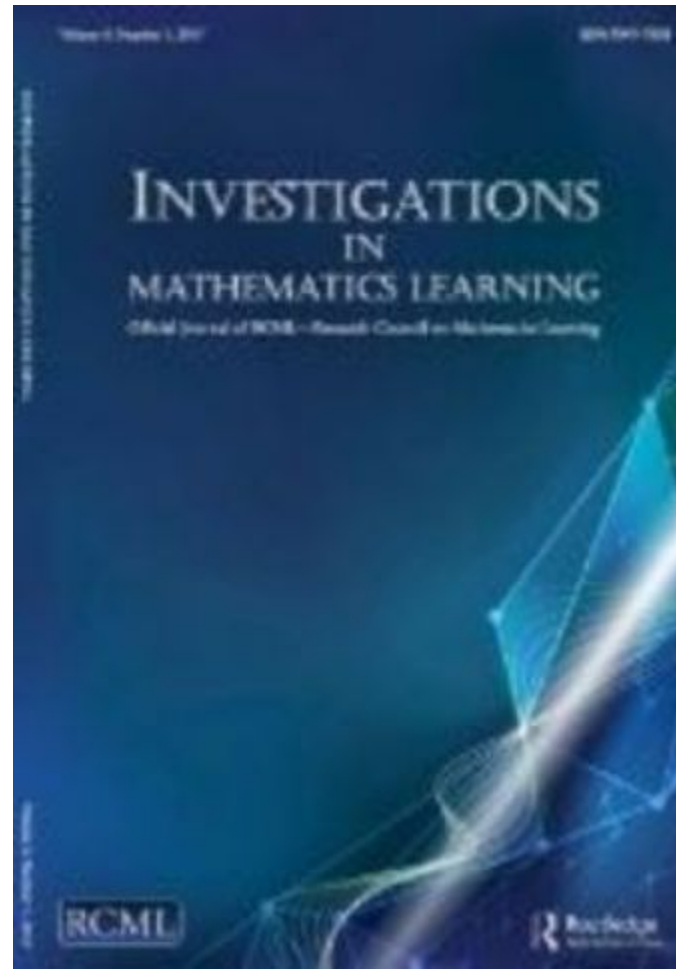

Descriptions of Offices

President-Elect

The President-Elect serves a one-year term prior to serving a two-year term as President and then a final one-year term as Past-President. The President-Elect has the following roles: presiding in the absence of the president, aiding the president in executive responsibilities, leading the process of potential changes to the Constitution and By-Laws, and facilitating the elections process.

VP Conferences

The VP Conferences serves a two-year term and assumes responsibility for coordinating conferences. Some of these responsibilities include: serving as chairperson of the Conference Committee, soliciting proposals for annual conference sites, and assisting in the development of conference programs.

Treasurer

The Treasurer serves a two-year term and maintains accurate records of income and expenses for the fiscal year. The treasurer also prepares a financial report for the Annual Business Meeting.

Conference Committee

Conference Committee members serve a three-year term and assist in conference processes, including identifying potential conference locations, conducting evaluations of conferences, and identifying potential Wilson and Founder's lecturers.

Publications Committee

Publication Committee members promote, improve, and contribute to the publication landscape of RCML and the mathematics education community. This includes the Investigations in Mathematics Learning journal, Intersections Point newsletter, and RCML proceedings.

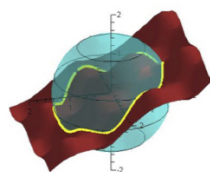
